

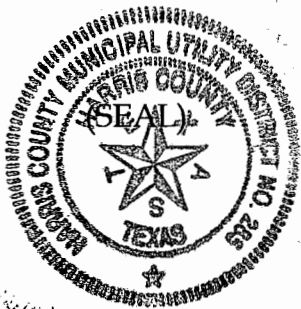
NOTICE OF MEETING

HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 285

The Board of Directors of Harris County Municipal Utility District No. 285 will hold a regular meeting on **Monday, September 19, 2016, at 6:30 p.m.**, at Allen Boone Humphries Robinson LLP, 3200 Southwest Freeway, Suite 2600, in the Neches Room, Houston, Texas, to discuss and, if appropriate, act upon the following items:

1. Minutes of prior meetings.
2. Hear statements from the public and receive written questions.
3. Financial and bookkeeping matters, including payment of the bills, review of investments, and amendment of budget, if necessary.
4. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
5. Discuss 2016 tax rate, set public hearing date, and authorize notice of public hearing regarding adoption of tax rate.
6. Adopt Resolution Requesting Appraisal of Property and Certificate of Estimated Appraised Value.
7. District website matters.
8. Security services report.
9. Development in the District.
10. North Channel Water Authority report.
11. Detention facilities report.
12. Garbage collection and recycling services, including report from Best Trash, LLC.
13. Engineer's report on construction projects in the District, including the following:
 - a. authorize design of facilities in the service area;
 - b. approve plans and specifications and authorize advertisement for bids for construction of facilities in the service area, including:
 - i. lift station no. 2 expansion;
 - ii. New Forest Town Center lift station (lift station no. 6);
 - iii. New Forest Town Center water and sanitary sewer extensions; and
 - iv. water plant drainage rehabilitation.
 - c. review bids and award contracts for construction of facilities in the service area, including:
 - i. wastewater treatment plant no. 2 expansion, including trifurcation.
 - d. approve pay estimates, time extensions, change orders, certificates of completion and final acceptance for projects in the service area, including:
 - i. water, sewer, and drainage facilities to serve Carpenters Landing, Section 7;

- ii. wastewater treatment plant no. 2 chlorine contact basin aeration replacement; and
 - iii. wastewater treatment plant no. 2 fine screen replacement;
 - e. update on clearing and grubbing to serve New Forest Town Center Tracts A and B;
 - f. electrical inspection proposal;
 - g. deeds, easements, plats, surveys, and/or consents to encroachment;
 - h. utility commitment requests;
 - i. update on bond application no. 11; and
 - j. update on surplus funds application.
14. Operator's report, including:
- a. update on operation, maintenance, and repair of District water, sanitary sewer, and storm water facilities; and
 - b. update on customer billing and collection.
15. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
16. Approve Interlocal Agreement with Harris-Galveston Subsidence District.
17. Approve Annual Report and authorize filing of same in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
18. Annual Review of Procedures for Continuing Disclosure Compliance.
