 - i. lift station to serve tract located off Wallisville Road east of Carpenters Landing;
 - ii. detention pond and storm water pump station to serve tract located off Wallisville Road east of Carpenters Landing; and
 - iii. waterline extension and forcemain to serve tract located off Wallisville Road east of Carpenters Landing.
 - c. review bids and award contracts for construction of facilities in the service area, including:
 - i. water plant no. 1 drainage improvements;

- d. approve pay estimates, time extensions, change orders, certificates of completion and final acceptance for projects in the service area, including:
 - i. water plant no. 1, Phase 3.
- e. wastewater treatment plant discharge permit renewals;
- f. deeds, easements, plats, surveys, as-built certifications, appraisals, phase I environmental assessments, consents to encroachment, and utility commitment requests; and
- g. proposals for engineering services.
- 13. Harris County Fresh Water Supply District No. 51 water plant rehabilitation and upgrade project.
- 14. Development of Geographic Information System.
- 15. Operator's report, including:
 - a. operation, maintenance, and repair of District water, sanitary sewer, and storm drainage facilities;
 - b. sanitary sewer manhole survey;
 - c. customer billing and collection;
 - d. smart meter installation program; and
 - e. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
