- e. review and approve report on electricity consumption and energy efficiency measures and take any necessary action;
- f. deeds, easements, plats, surveys, as-built certifications, appraisals, phase I environmental assessments, consents to encroachment, and utility commitment requests;
- g. development of geographic information system; and
- h. proposals for engineering services, including proposal for design of wastewater treatment plant conversion to bleach.
